

Exciting Changes Coming to Lakehurst Park!

2021 is the year that Lakehurst Park finally gets its irrigation system replaced, and other changes are being considered as well. On December 11th members of the Lakehurst Board met (over Zoom) with several staff members of Foothills Park & Recreation District. Foothills representatives included Colin Insley, Director of Parks, Sean Kitners, Parks Planner, Ron Hopp, Executive Director, Sarah McAfee, Park Operations and Mark Taylor with The Architerra Group, Landscape architect.

The broken concrete sidewalks that border the park have long been a concern for Lakehurst residents who walk through the park. Fixing the sidewalks is a delicate situation because only half of the sidewalk belongs to Foothills, the other half belongs to the homeowner whose house borders the park.

The design team is investigating options to improve pedestrian movement through the park and to Harriman Lake with a



more centralized and accessible trail. Once the new sidewalks are installed, Foothills plans to keep the sidewalks clear of snow in the winter.

This is only for the sidewalks that border the park area, including the "diamonds." Sidewalks between the backyards of houses do not belong to Foothills, they belong to the houses they border.


Some other things that were discussed:

- Removing the old playground that was replaced with a newer, ADA accessible playground on the south side of Surrey.
- Removing the gazebo at the south end of the park and replacing it with a couple of park benches.
- Installing a concrete pad with a roof at the north end of the park (where the gate to Harriman Lake Park is) for bands to set up at future concerts in the park.
- Replacing some of the grass with a more drought-tolerant variety.
